Commissioner Sera said she would like to save the Old City Hall. The Commission discussed and will research, analyze, and bring something back on February 20, 2024. Commissioner Colson discussed looking at the big picture and the bigger plan and spending the money on something that will help the historic district and 2<sup>nd</sup> Street. The Commission listened to public comment.

Chamber of Commerce representative Doug Lindhout discussed the successful tree lighting and the decorating contest—the ballots are available at the Chamber. The Chamber hosts the Christmas Golf Cart Parade this year on December 23. Our tree in the City Park was purchased used, and it's starting to show signs of wearing out, so they are beginning to fundraise for a new tree. Commissioner Colson noted the Chamber is still hosting events to meet the local needs of the City.

Nature Coast Biological Station director Mike Allen discussed that Cedar Key Shoreline and Stormwater Design has been funded to reinforce 1st and G Street. Working on grants for preservation, there will be ten storm drains that will receive traps to catch debris from going into the ocean. Resilient Cedar Key is working on the adaptation plan and how to deal with the rise in sea level. The aquarium and discovery center on their first floor is being rebuilt.

Clerk's Office Interim Clerk Jennifer Sylvester discussed renewing the interlocal agreement with Tammy Jones, Supervisor of Elections and to continue to use the new City Hall for the elections. The election is April 2, and the 23 will be the runoff. Commissioner Colson Motioned to Renew the Interlocal Agreement with Tammy Jones. Seconded by Commissioner Sera. The Motion Passed Unanimously. The Commission asked about the status of the boat slips. The Public Works Supervisor, Jamie McCain, discussed the status. Interim Clerk Sylvester requested approval for the August 15, 2023, minutes. #### Proposed Revision to Take Home Auto Policy

Explanation: The Chief of Police claims that the requirement of auto insurance to be carried by the individual officers granted the right to use a take home vehicle is too expensive and burdensome on them. After further analysis of the City's insurance policies and inquiries to our insurance underwriters, we have redrafted the approved policy removing the requirement mandating officers to carry personal auto insurance coverage that covers the City's vehicles. The City Attorney believes that the City should be exempt from liability if the officer has an accident occurring in violation of the existing City of Cedar Key Take Home Vehicle Policy, and that the insurer would necessarily have to handle all litigation for the City unless and until it is determined that any act was done in violation of the Policy. In addition, the City Attorney believes that the auto policy regarding personal property covers the vehicles listed in the policy whether or not the damage occurred in violation of said Take Home Vehicle policy. We have submitted this question to the Insurance Company for verification just to assure that the Vehicle Take Home Policy Endorsement does not preempt our understanding of the vehicle property coverage.

Requested Action: Vote of the City Commission to adopt the revised Take Home Vehicle Policy 151-3(F) if it so desires.

Location of Policy: This new sub-paragraph shall be added to the end of section 151-3 (Cedar Key Police Department Standard Operating Procedure – Agency Owned Vehicle Utilization) following subparagraph 151-3 (E) as new subparagraph 151-3(F).

New Policy: 151-3 (F): Take Home Vehicle Policy

Notwithstanding Paragraph 151-3(E) above, in the sole discretion of the Chief of Police and dependent upon the availability of vehicles, officers may be granted permission to drive their assigned vehicles ("Take Home Vehicle") home, or to another commute location approved by the Chief of Police, provided the commute is no farther than the borders of Levy County or, in the sole discretion of the Chief of Policy, no more than 60 miles of travel one way from Cedar Key. Said permission must be granted in a writing signed by the Chief of Policy and acknowledged by the officer ("Authorization") on a calendar year basis, unless or until permission is terminated as set forth herein. Said Authorization shall also include the vehicle identification number (VIN) of the Take Home Vehicle assigned to the officer. If the officer changes or is assigned a new Take Home Vehicle, a new Authorization must be completed and signed before the vehicle is driven out of City limits. Except in true emergency situations, officers shall not use their Take Home Vehicles for personal use when outside City limits other than for a direct commute home and back. Prohibited activities include but are not limited to running errands, making other stops on the way home, or allowing passengers in the vehicle, etc. In addition, officers must comply with all other Cedar Key Police Department policies and procedures while operating the Take Home Vehicle during their commute, and while it is parked outside City limits. The assignment of a Take Home Vehicle is not a right, but a discretionary

privilege that can be terminated at any time, with or without cause, in the sole discretion of the Chief of Police.

New Policy: 151-3 (F): Take Home Vehicle Policy

Notwithstanding Paragraph 151-3(E) above, in the sole discretion of the Chief of Police and dependent upon the availability of vehicles, officers may be granted permission to drive their assigned vehicles ("Take Home Vehicle") home, or to another commute location approved by the Chief of Police, provided the commute is no farther than the borders of Levy County or, in the sole discretion of the Chief of Policy, no more than 60 miles of travel one way from Cedar Key. Said permission must be granted in a writing signed by the Chief of Policy and acknowledged by the officer ("Authorization") on a calendar year basis, unless or until

permission is terminated as set forth herein. Said Authorization shall also include the vehicle identification number (VIN) of the Take Home Vehicle assigned to the officer. If the officer changes or is assigned a new Take Home Vehicle, a new Authorization must be completed and signed before the vehicle is driven out of City limits. Except in true emergency situations, officers shall not use their Take Home Vehicles for personal use when outside City limits other than for a direct commute home and back. Prohibited activities include but are not limited to running errands, making other stops on the way home, or allowing passengers in the vehicle, etc. In addition, officers must comply with all other Cedar Key Police Department policies and procedures while operating the Take Home Vehicle during their commute, and while it is parked outside City limits. The assignment of a Take Home Vehicle is not a right, but a discretionary privilege that can be terminated at any time, with or without cause, in the sole discretion of the Chief of Police.

IF AND WHEN THIS AUTHORIZATION IS TERMINATED, AT ANY TIME, THE FOLLOWING MUST BE COMPLETED BY THE CHIEF OF POLICE AND DULY RECORDED IN THE CITY OF CEDAR KEY RECORDS.
