## **Dear Commissioners:**

As a land trust, Florida's Nature Coast Conservancy's business is to own land in trust for preservation and conservation. The FNCC also encourages and assists local governments and other land trusts in the acquisition and preservation of environmentally endangered lands suitable for preservation or conservation. This is our mission.

A good part of the City of Cedar Key's purpose / mission is the safety and welfare of its residents. In keeping with this, the City of Cedar Key interacts with the Federal Emergency Management Agency with its Community Rating Service rankings and attempts to lessen flooding and decrease residents' flood insurance costs. Our purposes align.

Currently, FNCC-owned land accounts for a large part of the points earned by the City in its Community Rating Service Activity 420: Open Space Preservation.

These points account for 340 of 649 total overall points the City has earned. FNCC-owned properties make up 69.6 acres of the total acres in the flood plain (105.64). Since these 69.6 acres are also in their natural state, the City may well have earned extra point credits. Thus, FNCC land accounted for at least 70%, and likely closer to 80%, of the CRS credits from the Activity 420, more than half of the total initial points.

We wish to augment those points and further the City's FEMA / CRS efforts. We wish Cedar Key to be the greenest it can possibly be. We hope you wish the same, as well as bettering your CRS rating for all residents' benefit.

The Florida's Nature Coast Conservancy Board of Directors wishes to annex the Cull Preserve property into the City of Cedar Key. We believe such action is in the best interests of the residents of Cedar Key, the City itself, and well within our FNCC mission.

The Cull Preserve's specifics are noted on the attached Levy County Property Appraiser image.



AN ORDINANCE TO PROVIDE FOR THE ANNEXING OF CERTAIN PROPERTY INTO THE CITY OF CEDAR KEY; PROVIDING THE DESCRIPTION OF THE ANNEXED PROPERTY; PROVIDING THAT THE ANNEXED AREA BE SUBJECT TO ALL LAWS AND REGULATIONS AND ENTITLED TO ALL BENEFITS AND PRIVILEGES; PROVIDING AN EFFECTIVE DATE.

Ordinance 546 changes the current land use designation from County Residential to City Residential. Motion to approve Ordinance 546 provided by Commissioner Rosenthal. Vice Mayor Colson seconded. Motion approved 5-0.

- CITY CREDIT CARDS: The following name changes to the city's Visa credit cards were reviewed with Commissioner Rosenthal providing the motion and Vice Mayor seconded. The motion was approved 5-0.
  - 1. Card currently issued to Neil Polimeni will be changed to Cody Wetherington
  - 2. Card currently issued to James Custer will be changed to James McCain
  - 3. Card currently issued to Crystal Sharp, City Clerk, will stay suspended until further notice. It was also agreed that moving forward the monthly credit card payments would be set up on auto pay through. Both the name changes and auto pay will be coordinated through Drummond Bank. Mayor Davis asked that city attorney, Norm Fugate assist in developing a credit/charge card policy.
- NOVEMBER 2 AND DECEMBER 7 WORKSHOPS: Mayor Davis announced two upcoming workshops to be held in November and December. On November 2, the workshop will focus on how to appropriate the Rescue Plan Act dollars from the federal government for COVID relief and the city's current parking issues. The December meeting will focus on the marina.

City of Cedar Key Commission Workshop Minutes November 02, 2021 City Hall

Mayor Davis brought the Commission meeting to order at 6:00 pm

**PRESENT:** Mayor Heath Davis, Vice-Mayor Sue Colson, Commissioners Susan Rosenthal, Nancy Sera and Jim Wortham. Staff in attendance included: City Attorney Norm Fugate, Police Chief Virgil Sandlin, Fire Chief Robert Robinson, Telicia Winfield, and Building Clerk Jennifer Sylvester.

### **PUBLIC COMMENT**

**Covid Update:** Mayor Davis announced that city staff continues to sanitize the meeting room on a regular basis and prior to meetings. Ultraviolet, virus-preventing, lights have also been installed in the buildings air conditioning system. Quotes to add same type of lights to other city owned buildings has been requested and will be reviewed upon receipt.

**City Clerk Update:** Mayor Davis reported that the HR committee has received several applications for the open City Clerk position, of which most did not warrant vetting. The committee will continue its broad advertising campaign and report to the commission.

Mayor Davis confirmed the next commission workshop will be held on December 07, 2021, at 5pm.

## PARKING:

The goal of the workshop is to address the island's increased density and its associated increase in traffic. Police Chief Virgil Sandlin suggested two possible changes to the current parking layout:

- one side of the street parking on 4th Str. and
- paid parking along 1st Str. from A to B Streets and on Dock Street from the Big Deck to the Marina.

With the turning radius and clearance height of Cedar Key fire emergency vehicles, and the historic tree canopy throughout the city, it was suggested to have parking on one side of the street along 4<sup>th</sup> Str., staggering sides dependent on the tree canopy along the block.

Commissioner Jim Wortham noted that his concern was the misc. types of trailers parking along the streets. It was noted that the responsibility lies with the residents to park on their own property as opposed to the street.

Mayor Davis tasked Police Chief Sandlin, Fire Chief Robinson, and Public Works Supervisor McCain to return to the next meeting with a clear map of the area, painting / stenciling if necessary, and the costs associated to same. Their plan is to be presented at the December 7th meeting at 5pm.

## City of Cedar Key Commission Workshop Minutes November 02, 2021 City Hall

#### **COVID 19 RELIEF FUNDS:**

The city has received the first draw from the relief funds. The commission agreed, at the directive of the city's attorney, to set up a separate bank account with Drummond Bank specific to the use of the funds. It was also confirmed that the current authorized signers for the city's general operating account, Heath Davis, Sue Colson, and Susan Rosenthal, would be the approved signers for this account.

Cedar Key Water and Sewer District General Manager Chad Wisdom requested \$85,000, one third of the total cost, to repair the district's wastewater treatment plant that has serious deterioration in the concrete walls.

The following items were noted by the commission as potential uses for the funds. Discussion will continue at the next scheduled workshop:

- compensation for city hall staff considered "essential workers"
- hiring a community public health nurse who would be available for several years to care for cuts, broken bones, vaccine administration, health counseling, and more
- purchasing land off-island to place spoils from various city projects instead of paying transfer fees
- reimbursing those responsible for Cedar Key's wastewater testing protocol
- repaving of streets on the island's northwest corridor.
- building the shovel-ready project of public bathroom construction, a replica of the red-roofed bathroom now in the Marina, to be located at the foot of the bridge on D Street
- equipping all businesses with ultraviolet light filters that eliminate air-borne viruses.
- continuing the air purification system to all city facilities
- installing cameras at City Park to curb vandalism that has occurred since the advent of Covid
- furthering paid parking efforts in Cedar Key due to visitor increases.
- paying Zoom expenses
- paying for masks and signs required by Covid and the time necessary to produce them.
- regaining lost revenue from places such as the Community Center.
